PUBLIC QUESTION TIME

There were no written or verbal questions from any member of the public.

150. APOLOGIES

There were apologies for absence from Councillor Clare Cape.

151. DECLARATION OF INTEREST

No declaration of interest as defined by the latest approved Code of Conduct in the current approved Standing Orders was received.

152. MINUTES

The Minutes of the meeting held on Thursday 15 February 2018 were approved as a correct record and signed by the Chairman.

153. CHAIRMAN'S ANNOUNCEMENTS

The Chairman reminded Councillors that the next meeting (on 29 March) would take place at the Chippenham Museum.

154. PLANNING APPLICATIONS

RESOLVED that

- (i) The attached list of observations on planning applications be submitted to the Local Planning Authority.
- (ii) The following were noted:
 - Refusal of planning application 17/12043/FUL (erection of 66 dwellings, formation of access road, open space, landscaping and associated works – land at Methuen Park).
 - Approval of planning application 17/03417/OUT (outline planning for the erection of up to 1,000,000 sq ft of class B8 storage and distribution, employment space and associated infrastructure – land south east of Junction 17 of M4 Motorway).
 - The dismissal by the Planning Inspectorate of the appeal against refusal
 of planning permission for 17/01407/FUL (conversion of existing offices
 into 5 flats, including rear extension and raising the roof at 1 Langley
 Road).

155. CHIPPENHAM COMMUNITY AREA TRANSPORT GROUP (CATG)

(i) Councillors received a report on new requests for Highway improvements from the Administrative Services Officer – Planning (copy in Minute Book).

A proposal to support CATG Issues 6063, 5886 and 5942 was put forward and a vote was taken. The motion was carried.

RESOLVED that the following comments be forwarded to Wiltshire Council for consideration by the Community Area Transport Group:-

<u>Issue 5734</u> – emergency vehicles unable to park at front of Croft Court Residential Care Home.

- The Town Council does not support this request, in line with the recommendations made by the local Councillor at the CATG meeting on 27 February 2018.

<u>Issue 6063</u> – need for safe drop off zone outside Nursery in Lowden Avenue.

- The Town Council supports the Highway Officers recommendation for a time limited bay to be installed and agree a contribution of £750 towards the cost. However, there were some concerns raised regarding future enforcement. Councillors suggested this request could possibly be combined with a future request to reduce the cost.

<u>Issue 5886</u> – replace advisory crossing point near St. Peter's School with zebra crossing.

- The Town Council supports the Highway Officers recommendation for a formal assessment and agrees a contribution of £250 towards the cost of a pedestrian count.

<u>Issue 5942</u> – vehicles misdirected by sat nav. causing damage and disturbance, the Cloisters, Gypsy Lane.

- The Town Council supports this request and is happy for the Highway Officer to decide which of the two options suggested would be best. It agreed to a contribution of £62.50 towards the cost.
- (ii) On 22 June 2017 the PET Committee gave approval for the Town Council to investigate the process for a 20mph limit and static signage in the High Street via. CATG. Councillors received a verbal update requesting final approval to progress with this request from the Chairman. A proposal to support this request was put forward and voted upon. The motion was carried.

RESOLVED that the Town Council supports requesting a 20mph speed limit in the High Street made via the CATG process.

- (iii) The Chairman reported that the CATG Workshop held on Tuesday 6 March 2018 in the Town Hall had been well attended.
- (iv) Councillors received a report on the CATG meeting held on 27 February 2018 from Councillor John Scragg, the Town Council's appointed representative (copy in Minute Book).

156. LICENSING

Variation of a Premises Licence – Tesco Express, Hungerdown Lane SN14 0JH

Councillors gave consideration to the above Variation of Premises application received by Wiltshire Council to vary the Licence for the sale of alcohol (OFF sales) – 06:00 to 00:00 daily and the removal of embedded restricted hours on Christmas Day and Good Friday.
