

## CHIPPENHAM TOWN COUNCIL - FEES & CHARGES 2021/2022

### London Road Cemetery

The fees, payments and sums set out below apply where the person to be interred is, or in respect of whom the right is granted is, or before his/her death was, an inhabitant or parishioner of a Chippenham Town Council ward.

All fees, payments and sums due, at any time, for non parishioners are doubled, except where the Exclusive Right of Burial in a grave or vault was acquired at the single fee.

However, in special circumstances, and upon receipt of an application in writing, the rule for double fees may be waived in respect of the interment of a former inhabitant or parishioner of Chippenham. The determination of any such application shall be entirely at the discretion of the Chief Executive.

NB - all fees for burials at weekends, Bank Holidays or out of normal hours (subject to staff availability) are doubled.

### Exclusive Rights of Burial in Earthen Graves.

**2021-2022**

#### **A** Exclusive right of burial for a term of 99 years

Where the exclusive rights of burial is that of a still born child or a child whose age at the time of death did not exceeds 12 months.

**No charge**

Where the exclusive rights of burial is that of a child whose age at the time of death exceeded 12 months but did not exceeds 18 years.

**No Charge**

For the exclusive rights of a person exceeding 18 years in a single grave

#### **B** Exclusive right of burial for a period of 99 years of cremated remains in a grave space

### Interments

#### **A** For the interment in a grave or vault

Where the interment is that of a still born child or a child whose age at the time of death did not exceeds 12 months. Including Non Parishioners

**No Charge**

Where the interment is that of a child whose age at the time of death exceeded 12 months but did not exceeds 18 years.

**No Charge**

For the interment of a person exceeding 18 years.
