

London Road Cemetery

The 2026-2027 Fees and Charges have been prepared after comparative charges have been checked against similar providers. All charges are inclusive of VAT where appropriate.

The fees, payments and sums set out below apply where the person to be interred is, or in respect of whom the right is granted is, or before his/her death was, an inhabitant or parishioner of a Chippenham Town Council ward.

All fees, payments and sums due, at any time, for non-parishioners are doubled, except where the Exclusive Right of Burial in a grave or vault was acquired at the single fee.

However, in special circumstances, and upon receipt of an application in writing, the rule for double fees may be waived in respect of the interment of a former inhabitant or parishioner of Chippenham. The determination of any such application shall be entirely at the discretion of the Chief Executive.

NB - all fees for burials at weekends, Bank Holidays or out of normal hours (subject to staff availability) are doubled.
